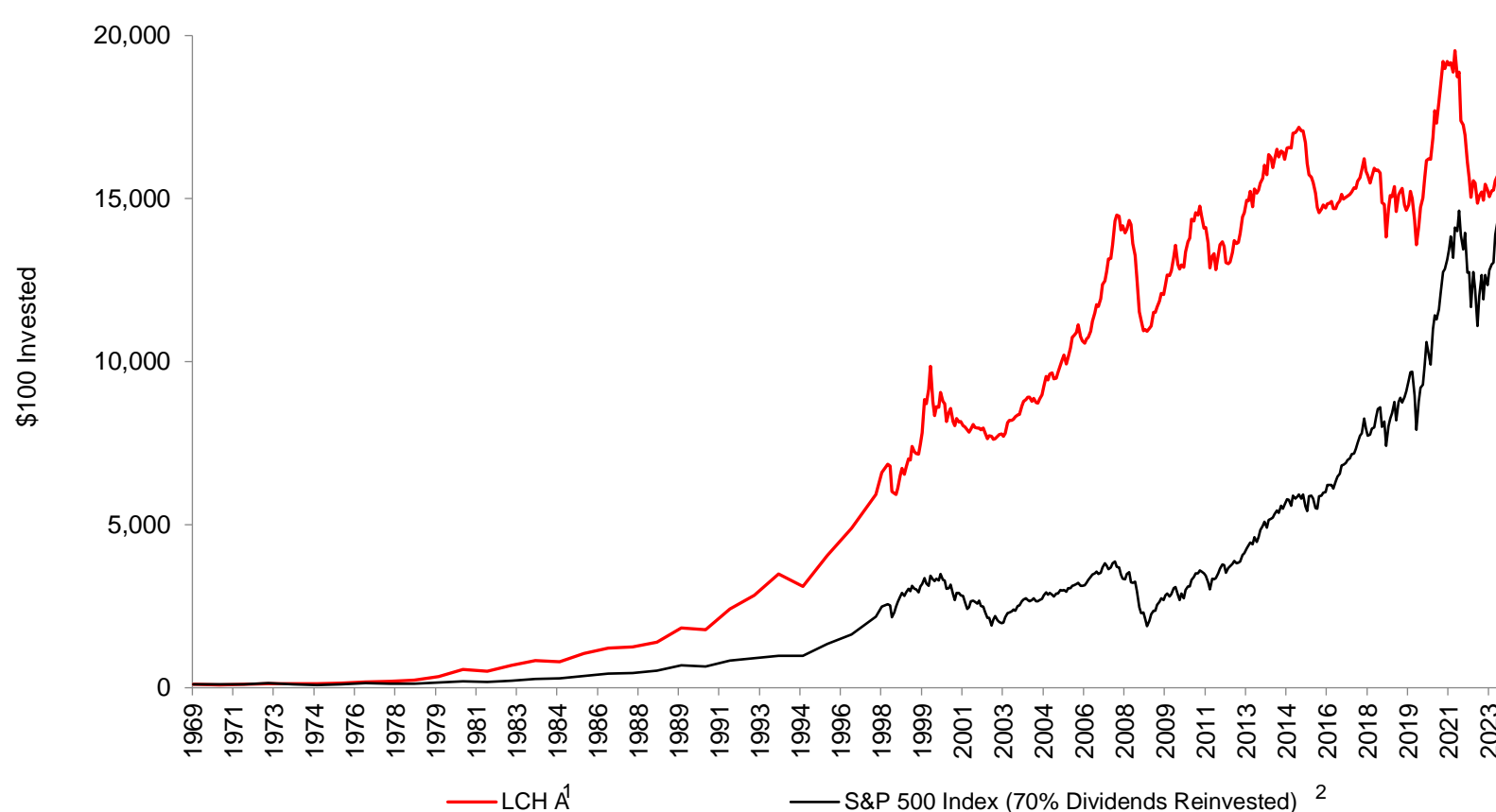


## Fund Description

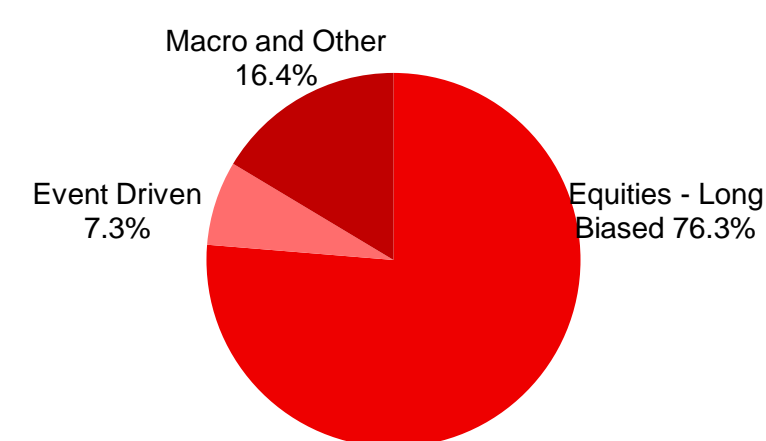

## Commentary

LCH returned (2.1%) in September and is +1.8% for 2023 YTD. Higher bond yields and more hawkish Fed rhetoric weighed on US equities but the fund's enhanced allocation to global macro managers was on the right side of these market trends (returning +2.5%), helping to cap losses during the month.

At the time of writing in early October the equal weighted S&P 500 index is negative for 2023 YTD, indicative of the narrow breadth of the double-digit return by the regular index.

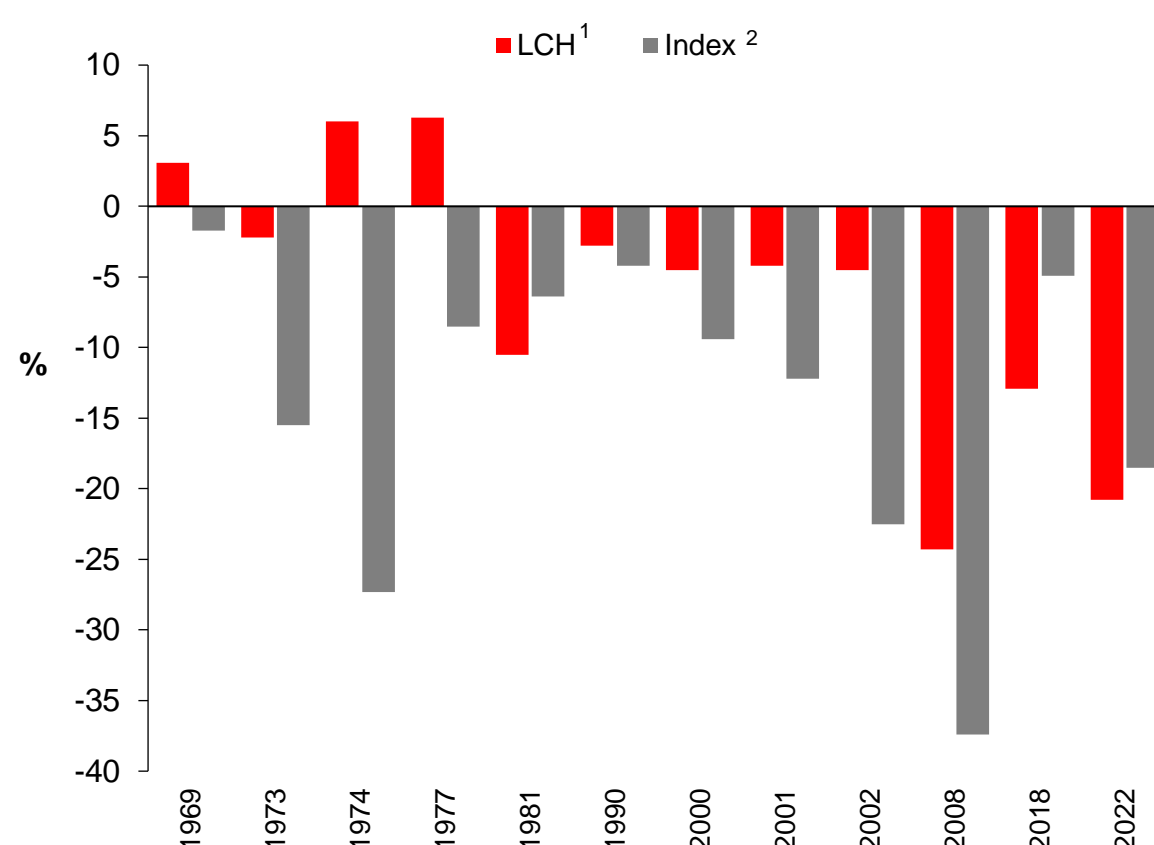

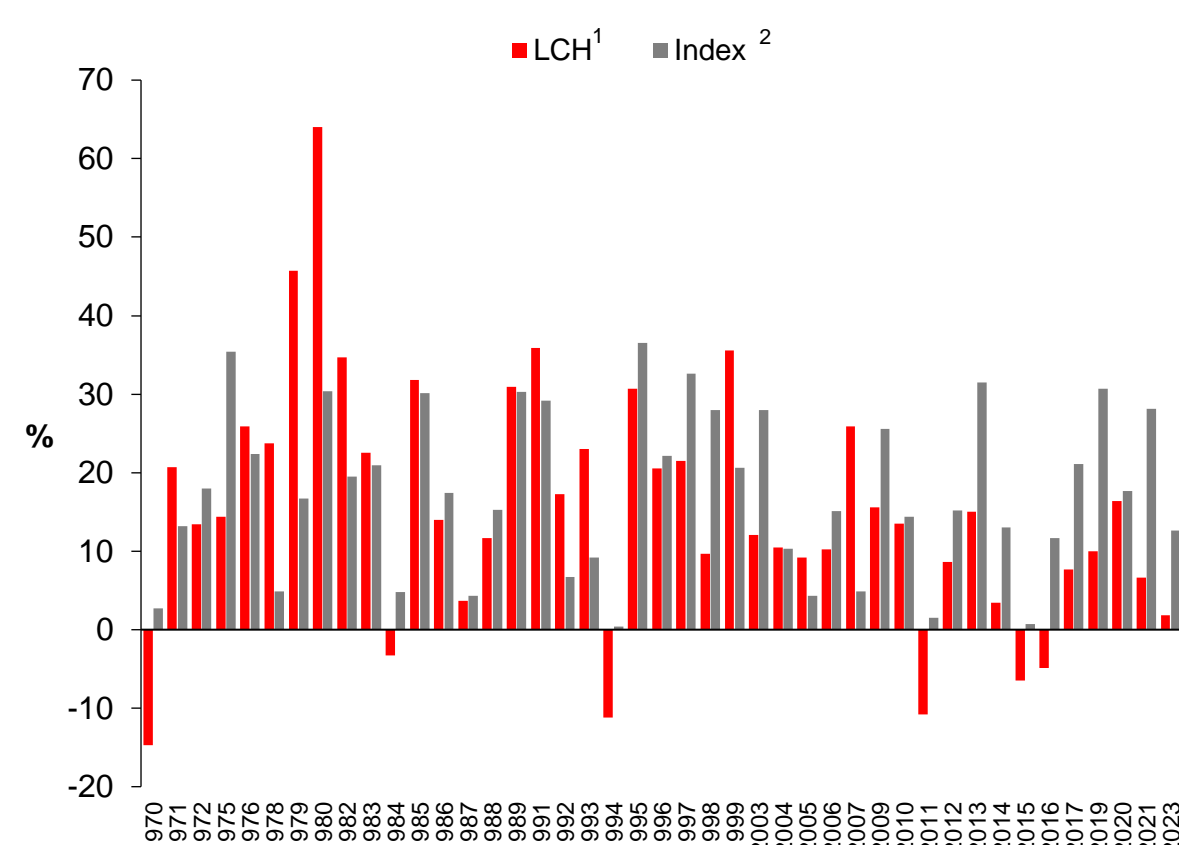
