



#### Commentary

LCH returned +2.0% in February and is +2.8% for 2024 YTD.

There were notably strong contributions from the fund's group of 'Macro and Other' managers (+3.1% on a weighted basis), with one top 5 manager in particular leaning into the strong equity market to deliver a +8% return for the month and 14% YTD. The allocation to this area was enhanced further during the month with a new 2.5% NAV allocation to a very well-established manager focused on 'alternative trend following' in liquid markets.

Equities-Long Biased managers were also profitable (+2.2% on a weighted basis with approx. 50% net exposure) driven by a diversified set of themes.




